## NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.0300 per \$100 valuation has been proposed by the governing body of GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2.

PROPOSED TAX RATE \$0.0300 per \$100 NO-NEW-REVENUE TAX RATE \$0.0303 per \$100 VOTER-APPROVAL TAX RATE \$0.0313 per \$100

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2 from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2 is not proposing to increase property taxes for the 2021 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 2, 2021 AT 9:00 AM AT Randle Rather Building - 1st Floor Training Room, 427 Saint George, Gonzales, Texas.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Commissioners of GONZALES COUNTY EMERGENCY SERVICES DISTRICT #2 at their offices or by attending the public meeting mentioned above.
